

- Represent and promote the interests of Junior Doctors in Europe
- Exchange information and develop a common approach, and formulate common views on relevant topics e.g. the European medical workforce, postgraduate medical training and working conditions
- Improve and develop relations between Junior Doctors in European countries
- Protect and improve standards of healthcare in Europe

Postgraduate Training Survey Results

- A survey with the aim evaluating PGT in different countries was conducted by EJD last year.
- All member countries were asked questions about process of application, supervision of residency posts, residency status and supervision of quality, flexibility during residency, assessments during residency and length of medical training.
- Main results were presented at this GA and will be ready for public presentation later in 2018.



Movement of doctors - topic debate

- Dr. Mariana Pinto da Costa, from EFPT presented the main results of their study investigating main reasons motivating JDs to move to other European countries.
- The key findings of the study were:
 - Top host countries have higher incomes
 - 2/3 of psychiatry trainees across Europe plan to migrate
 - Higher migratory tendencies in south/east Europe as opposed to north/west
 - Main reason for departure is academic/training opportunities
 - Main reason for remaining is personal/family reasons
 - Only 8.7% of those who left planned to return to their home countries



Brexit

 The EJD President presented on "The Pan European Medical Workforce" at an event regarding "Keeping EU healthy" post-Brexit on 23rd May in the European Parliament. In particular she spoke highlighting the need to maintain provisions of the MRPQ for all doctors moving between the UK and the EU beyond March 2019

 Work is underway to update the data held on the European Medical Mobility website (http://www.medicalmobility.eu) from the EJD member delegations. The website will be relaunched in late 2018.



Working groups

Medical Leadership

 Medical Leadership WG continued their work on creating a solid basis for promoting the inclusion of medical leadership on medical training programs.

Free movement of doctors

 Free movement of doctors WG kept working on the issues around restrictions to medical mobility in Europe and started drafting a statement to be worked on during the next months.
