Also Prof. Peter Westerhom from Uppsala, Sweden, wished us a fruitful meeting and will join us next fall at Lake Bled with presentation on Ethics in Occupational Medicine.

2. Welcome

Welcome was expressed to all participants and our thanks to the Romanian organizers – dr. Damian Fotache and his colleagues. President of the section repeated his key objectives for working groups from Lisbon's meeting:

- 1. promotion and harmonisation of postgraduate training and objectives, together with EASOM;
- 2. enhance the position and promotion of our Section in political networks in the EU;
- 3. promotion of high quality occupational healthcare for all EU citizens;
- 4. to reply on changing working environment and position of workers in the EU.

We accepted Ewan Macdonald's opinion that redefinitions of work and workers are needed and Tom O'Connell's statement that the priority should be devoted to WG2; WG1 should make clear health care

professionals are not the same as occupational physicians and occupational health nurses; WG3 and WG4 should be merged.

3. Welcome speech on behalf of the Romanian Society of Occupational Medicine

was presented by dr. Damian Fotache. He expressed his enthusiasm for organizing this meeting and also provoked UEMS Section with his perspectives.

4. Collaboration with EASOM

André Weel, EASOM Secretary, presented EASOM – European Association of Schools of Occupational Medicine. It was founded in 1993. It has got 33 members with different types of professions. Projects: LdV, Epi, EMUTOM. First EASOM Summer School was organized in Dresden 2001 - TRAINING MODULE FOR OCCUPATIONAL PHYSICIANS IN RISK COMMUNICATION, the next one will be TEACHING ETHICS IN OCCUPATIONAL MEDICINE in Rouen, France, 25 - 27 August 2011. Website: www.easom.org, EASOM Bulletin is also spread electronically. UEMS Section of OM and EASOM need to be in close cooperation because of common topics – Quality of practice and training, Criteria for training, accreditation and harmonization. The future tasks are strengthening OM in basic medical curriculum, making OM attractive for medical students and graduates, common research and development projects, (re)definition of professional competencies in a changing world. EASOM Board discussion issues are: membership, finance, communication, undergraduate training, certification system for schools (like in Public Health?). Specific courses are organized – aeronautic, diving, ionizing radiation.

7. Acquisition of new members

Secretary of the Section reported on many activities to acquire all of 27 EU member countries to join our UEMS Section. The secretary hopes that a letter to Medical Chambers of all missing countries will find a fruitful ground. Unfortunately the new UEMS's assistant who is devoted to the contacts to the sections and boards did not bring us any new data, on the contrary, he asked us to inform him with the representatives in our UEMS Section.

8. Accreditation System of UEMS

Jacques and Andre sent us a draft proposal about accreditation requirements.

After a long discussion a procedure of nomination was set up:

- To nominate five members of the Advisory Committee + Secretary (non-voting)
- From five different countries
- Experienced in training
- 3 UEMS + 2 EASOM Board members

- Chair: member of UEMS
- To establish electronic process, financed by UEMS Section of OM

It was decided that:

- UEMS members of Advisory Committee are: Consol Serra (Spain), Nikki Cordell United Kingdom), Milan Tuček (Czech Republic)
- Secretary of the Committee is UEMS Section's secretary Alenka Škerjanc (Slovenia)
- EASOM Board will nominate their members (not from Spain, Great Britain or Czech republic)

The new established Advisory Committee will elect their president (UEMS member) after receiving proposals from the EASOM Board. Their working procedure will be also made by committee itself, proposal will be given by Jacques and Nikki. At least 3 votes of 5 are needed to decide, a member cannot assess his/her country's programmes. At least 3 votes of 5 are needed to decide, a member cannot assess his/her country's programmes.
